What is the purpose of this update?

This document tells you how the Kernel NZ Level 9 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The Kernel NZ Level 9 Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX Emerging Opportunities Index.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 28 August 2019 and did not make any further contributions. On 31 December 2019, Emma received a return after fund charges were deducted of \$1,002 (that is 10.02% of her initial \$10,000). This gives Emma a total return after tax of \$988 for the period.

Notes
