### What is the purpose of this update?

This document tells you how the Kernel NZ Level 9 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The Kernel NZ Level 9 Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX Emerging Opportunities Index.

# What are the risks of investing?

#### Risk indicator for the Kernel NZ Level 9 Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

#### What fees are investors charged?

Investors in the Kernel NZ Level 9 Fund are charged fund charges. In the year to 31 March 2020 these are estimated to be:

Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Small differences in fees and charges can have a big impact on your investment over the long term.

#### Example of how this applies to an investor

Emma had \$10,000 in the fund on 28 August 2019 and did not make any further contributions. On 31 March 2020, Emma incurred a loss after fund charges were deducted of \$2,830 (that is -28.30% of her initial \$10,000). This gives Emma a total loss after tax of \$2,859 for the period.

# **Notes**
