What is the purpose of this update?

This document tells you how the Kernel S&P Global 100 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Kernel S&P Global 100 Fund invests in globally listed multi-national, blue chip companies and is designed to track the S&P Global 100 ex Controversial Weapons Index (NZD).

What are the risks of investing?

Risk indicator for the Kernel S&P Global 100 Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Emma had \$10,000 in the fund on 15 July 2020 and did not make any further contributions. On 30 September 2020, Emma received a return after fund charges were deducted of \$61.18 (that is 0.61% of her initial \$10,000). This gives Emma a total return after tax of \$39.37 for the period.
