# What is the purpose of this update?

This document tells you how the Kernel S&P Kensho Electric Vehicle Innovation Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

The Kernel S&P Kensho Electric Vehicle Innovation Fund invests in U.S. Listed companies involved in the electric vehicle sector and the industries supporting it. It is designed to track the S&P Kensho Electric Vehicles Index (NZD).

Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Small differences in fees and charges can have a big impact on your investment over the long term.

#### Example of how this applies to an investor

Emma had \$10,000 in the fund on 17 February 2021 and did not make any further contributions. On 31 March, Emma incurred a loss after fund charges were deducted of \$694.45 (that is -6.94% of her initial \$10,000). This gives Emma a total loss after tax of \$703.44 for the period.
