Description of this fund


The Kernel S&P Global Dividend Aristocrats Fund invests in globally listed multi-national, blue chip companies and is designed to track the S&P Global Dividend Aristocrats Quality Income DM ex KR Index (NZD).

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Emma had \$10,000 in the fund on 15 July 2020 and did not make any further contributions. On 31 March 2021, Emma received a return after fund charges were deducted of \$2,333.43 (that is 23.33% of her initial \$10,000). This gives Emma a total return after tax of \$2,230.01 for the period.

Notes

1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 4 months ofmarket index returns.
