# What is the purpose of this update?

This document tells you how the Kernel S&P Global Clean Energy Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Kernel S&P Global Clean Energy Fund invests in globally listed companies involved in clean energy related businesses, including energy production and energy equipment. It is designed to track the S&P Global Clean Energy Index (NZD).

## What are the risks of investing?

# What fees are investors charged?

Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Small differences in fees and charges can have a big impact on your investment over the long term.

#### Example of how this applies to an investor

Emma had \$10,000 in the fund on 16 June 2021 and did not make any further contributions. On 30 June, Emma received a return after fund charges were deducted of \$402.24 (that is 4.02% of her initial \$10,000). This gives Emma a total return after tax of \$412.62 for the period.
