#### What is the purpose of this update?

This document tells you how the Kernel NZ 20 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The Kernel NZ 20 Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX 20 Index.

# What are the risks of investing?

Small differences in fees and charges can have a big impact on your investment over the long term.


#### Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 October 2020 and did not make any further contributions. On 30 September 2021, Emma received a return after fund charges were deducted of \$1105.33 (that is 11.05% of her initial \$10,000). This gives Emma a total return after tax of \$1032.63 for the year.

#### **Notes**

1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 2 years and 11 months of market index returns.
