What is the purpose of this update?

This document tells you how the Kernel NZ Small & Mid Cap Opportunities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Kernel NZ Small & Mid Cap Opportunities Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX Emerging Opportunities Index.

What are the risks of investing?

Risk indicator for the Kernel NZ Small & Mid Cap Opportunities Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 October 2020 and did not make any further contributions. On 30 September 2021, Emma received a return after fund charges were deducted of \$3,114.21 (that is 31.14% of her initial \$10,000). This gives Emma a total return after tax of \$3,034.72 for the year.

Notes
