### Kernel Global Green Property Fund

#### Fund update for the quarter ended 31 December 2021

This fund update was first made publicly available on 10<sup>th</sup> February 2022.

#### What is the purpose of this update?

This document tells you how the Kernel Global Green Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

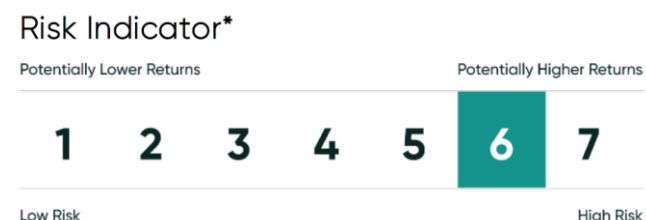
#### Description of this fund

The Kernel Global Green Property Fund invests in globally listed real estate investment trusts (REITs) and real estate operating companies (REOCs) traded globally. Company weights are modified to tilt a higher investment to companies with stronger ESG characteristics as calculated by GRESB. The Fund targets a position of being fully hedged back to New Zealand dollars. It is designed to track the Dow Jones Global Select Green RESI NZD Hedged.

#### What are the risks of investing?

Risk indicator for the Kernel Global Green Property Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.

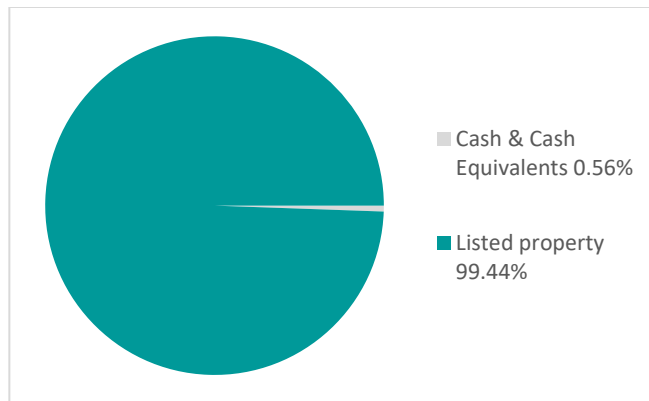
#### Example of how this applies to an investor

Emma had \$10,000 in the fund on 16 June 2021 and did not make any further contributions. On 31 December, Emma received a return after fund charges were deducted of \$571.45 (that is 5.71% of her initial \$10,000). This gives Emma a total gain after tax of \$552.54 for the period.

### Notes

1 Market index returns have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 6 month of market index returns.
