
Description of this fund

The Kernel S&P Global Clean Energy Fund invests in globally listed companies involved in clean energy related businesses, including energy production and energy equipment. It is designed to track the S&P Global Clean Energy Index (NZD).

What are the risks of investing?

Risk indicator for the Kernel S&P Global Clean Energy Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Emma had \$10,000 in the fund on 16 June 2021 and did not make any further contributions. On 31 December, Emma incurred a loss after fund charges were deducted of \$306.94 (that is -3.07% of her initial \$10,000). This gives Emma a total loss after tax of \$358.01 for the period.
