What is the purpose of this update?

This document tells you how the Kernel S&P Kensho Electric Vehicle Innovation Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Kernel S&P Kensho Electric Vehicle Innovation Fund invests in U.S. Listed companies involved in the electric vehicle sector and the industries supporting it. It is designed to track the S&P Kensho Electric Vehicles Index (NZD).

Example of how this applies to an investor


Emma had \$10,000 in the fund on 17 February 2021 and did not make any further contributions. On 31 December, Emma incurred a loss after fund charges were deducted of \$1,439.28 (that is -14.39% of her initial \$10,000). This gives Emma a total loss after tax of \$1,516.15 for the period.
