What is the purpose of this update?

This document tells you how the Kernel NZ 50 ESG Tilted Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Kernel NZ 50 ESG Tilted Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX 50 Portfolio ESG Tilted Index.

What are the risks of investing?

Risk indicator for the Kernel NZ 50 ESG Tilted Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

What fees are investors charged?

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Emma had \$10,000 in the fund on 14 July 2021 and did not make any further contributions. On 31 December 2021, Emma received a return after fund charges were deducted of \$205.00 (that is 2.05% of her initial \$10,000). This gives Emma a total return after tax of \$166.00 for the period.

Notes

1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 7 months of market index returns.
